

Team Midnightsun – CONTRACT The Frisian Solar Challenge 2008

This document declares the terms of agreement between the "Team Midnightsun", receiving financial/material support, and sponsors, suppliers or supporters. The team consists of individuals who can be related or not related to Högskolan Dalarna in any ways. Högskolan Dalarna has, as university/high school, received the invitation to participate in the Frisian Solar Challenge 2008 and has in full delegated this invitation to the "Team Midnightsun".

1. The received financial/material support is used by the "Team Midnightsun". Hence, the team members can use the financials for any of their purposes related to the project aiming to participate in the "Frisian Solar Challenge 2008".
2. No directions have to be accepted by the team members related to the usage of the financials from the sponsors. The members of the "Team Midnightsun" have every right to use the received financials and, due to the policy of Högskolan Dalarna, they have to be considered independently in any means from this organization. No liability can be accepted by Högskolan Dalarna according to any terms related to the financial support and our actions.
3. The services of the "Team Midnightsun" towards the undersigned of this contract are consisting of four different parts of advertisement.
 The **first part** is the presentation of the company, related to the undersigned, by means of placing the logo on the homepage of the [European Solar Engineering School](#). The size and location of this logo within the homepage are the consideration of the members of the "Team Midnightsun".
 The **second part** is the presenting of the logo related to the undersigned on the boat, participating in the "[Frisian Solar Challenge 2008](#)". Advertisement on the boat will be carried out in form of stickers and/or flags, which has to be provided by the undersigned. The placement and size of the area available for the undersigned is depending on the final configuration of the boat and can be altered due to the function and/or mission. Optimal placement and clear visibility has to be ensured by the "Team Midnightsun".
 The **third part** is the presenting of the logo related to the undersigned on the trailer for the boat. The placement and size of the area available for the undersigned is depending on the final configuration of the trailer.
The second and the third part can, after the F S C 2008, be used or not used, due to the then actual mission, by the undersigned. The actual use is solely determined by the "Team Midnightsun" in discussion with resp. undersigned.
 The **fourth part** consists of reduced costs for the undersigned, when and if the boat with trailer and part of the team is engaged in other events ordered by the undersigned. A separate contract must be written and agreed in these cases.
4. In case of any unpredictable event (e.g. damage of the equipment, transport vehicle etc.) which can obstruct the "Team Midnightsun" in their efforts to be presented on the "Frisian Solar Challenge 2008", the remaining part of the financial and/or material support and the money which can be received back (e.g. motor, batteries) will be divided equally between our sponsors and sent back on demand. Due the nature of our services (see term 3), we cannot be obliged to return back the whole amount of financial support in any of these unpredictable events.
5. For the four of our services (term 3) the undersigned should pay us the minimum weigh of 5000 SEK/ 750 USD/ 537 EUR.
 However, additional financial support above the minimum weigh can ensure the undersigned to have larger area on the boat and trailer; the maximum area is determined by the number of sponsors and final size of the hulls. The additional financial support is based on the interest of the undersigned.
6. For any combined financial/material or material support the value will be determined and related in the same way as term 5.
7. All responsibility for the proper use of the financial support and the observation what is declared in this contract falls on the following members of the "Team Midnightsun":
